FOOTNOTES

- (1) 3-cart bundle is the default residential service and includes one 95-gallon cart each for source-separated refuse, recycling & organic waste provided by Contractor; bagged food waste permitted in organic cart. Dwellings not billed via the County property tax bill will be billed directly by Contractor, quarterly in advance.
- (2) Single family rate applies to dwellings in mobile home parks that are direct billed individually by Contractor.
- (3) Containers (carts & bins) must be no more than level full with lids closed. C&D waste and animal waste prohibited, except for animal waste for household pets.
- (4) Detached single family service billed on County property tax bill. Any services direct billed by Contractor are subject to a billing fee for each quarterly billing.
- (5) Existing optional green waste cart service replaced by organic waste cart service effective 10/1/22.
- (6) Service category applies to dwelling units: (a) with common walls such as duplexes, triplexes, condominiums, townhomes, apartments, hotel & motel units; also applies to mobile home park dwellings; (b) serviced individually, and (c) receiving one bill for all units on account. Also applies to mobile home park dwellings receiving individual pick-up and a master bill to a single account. All other units billed as Single Family dwellings.
- (7) Service billed monthly in arrears; deposit and/or advance payment may be required of delinquent accounts.
- (8) After written notice to customer posted on cart.
- (9) Organic waste recycling required for all commercial services. Organic wastes (green waste, food waste & mixed organic waste) are to be source-separated and free of contamination; mixed organic waste containers may include bagged food waste. Available organic waste services for specific generators:
- (a) Required for Food establishments: (a) Food waste service, AND (b) green waste service, if applicable.
- (b) <u>Required for Non-food establishments</u>: (a) green waste service, OR (b) mixed organic waste service as applicable.
- (c) <u>Required for Multi-family complexes</u>: mixed organic waste service ONLY (or with separate green waste and food waste containers by special arrangement with Contractor.
- (d) <u>Required for Cannabis establishments</u>: green waste service for cannabis waste AND other organic service as applicable.

FOOTNOTES, continued

- (10) Bins cleaned or exchanged once annually at no charge upon request.
- (11) For each 2-, 3- or 4-CY bin subscription, regardless of the number of weekly pick-ups, customer receives one 3CY recycle bin collected once weekly. Additional recycle bins or weekly recycling bin pickups available for additional fees. Customer may substitute a 2CY bin, however no price difference for substitutions.
- Examples: (a) One 3CY recycle bin provided for subscription of one 2CY refuse bin collected 1xWeek; (b) One 3CY recycle bin provided for subscription of one 3CY bin collected 6xWeek; (c) Two 3CY recycle bins provided for subscription of two 4CY refuse bins collected 2xWeek.
- (12) Source-separated green waste, food waste or mixed organic waste free of non-compliant waste; requirements strictly enforced.
- (13) The disposal of cannabis waste is regulated by the State of California. State regulations allow collection of cannabis waste with other green waste if processed at a permitted green waste facility. The cannabis waste documentation fee covers the hauler's record keeping cost. Documentation fee applies to each collection visit regardless of the number of containers collected at the visit.
- (14) For tons delivered to a solid waste facility for diversion. Fee per ton is the sum total of listed fees (a) thru (e).
- (15) Return trip to service inaccessible box/compactor or relocate at customer's request.
- (16) City's administrative charge to collect delinquent waste charges on the County tax bill; allocated among the accounts eligible to be collected in this manner as a lien against the property.
- (17) City's administrative cost to levy an assessment for solid waste fees on eligible properties; allocated equally among eligible single family properties placed on County property tax bill.
